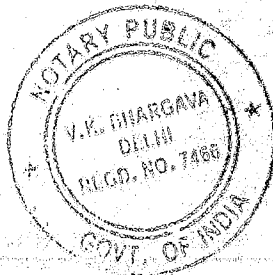
That those workman employed by me / my company and performing the same and similar Work as the workmen directly employed by the establishment have been same wages to the direct employed workmen.
